**OLD BUSINESS**

**J. Paul Moore – Case Update**

She has responded to this and lodged the record from the last hearing. At this point the Court will either direct new briefs to be filed, ask for oral arguments or rule on the record. Ms. Ford will try to push the case along. Dr. Moore will continue to be able to practice under supervision.

**NEW BUSINESS**

**Request for Formal Ruling of Title Usage – K. Infield**

Karen Infield is using the term "therapist" and was asked by the director of the Counselor Board, Ann Thomas, to use the term "psychotherapist". She requested clarification from the Board of the proper term to use. Discussion followed. Ms. Ford stated that the term "therapist" is a

generic term and licensees can use this term without any repercussions. Mr. Dwight Sperry made a motion to correspond with Ms. Infield stating that the terms are not a controlled designation and that the Board takes no position of which term to use. Ms. English seconded the motion. The motion passed unanimously. Ms. Infield may use the term “therapist”.

### **Request for Board Approval of Pre-Doctoral Internship site – Angela Stillwell**

Dr. Suzanne Throesch corresponded with the Board concerning an internship for Angela Stillwell. The site does not meet the requirements of the Rules and Regulations. Dr. Throesch recognized that there would be only one supervising psychologist on site. She is requesting that the Board approve this internship. Ms. English made a motion to table this request and to get more information from Dr. Throesch and from Angela Stillwell. Dr. Joe Alford seconded the motion. The motion passed unanimously.
